As part of the WebTrust examination services performed from May 2024 to July 2024 and provided to IdenTrust, in accordance with relevant American Institute of Certified Public Accountants (AICPA) standards, IdenTrust has asked Schellman & Company, LLC ("Schellman" or "we") to provide certain information to assist in its efforts to provide interested parties with information about the individuals who performed work as part of the examinations. Independence

We are independent of IdenTrust and its CA clients for the professional engagement period as required by the AICPA Professional Standards.

Educational Level and Professional Experience

Schellman's professionals serving IdenTrust have all received degrees from an accredited college or university. As of the date of this letter, Schellman service delivery personnel have the following average years of professional experience and number of completed assessments:

Methodologies, Policies and Procedures

Personnel on the WebTrust examination engagements complied with Schellman internal policies and procedures,

which are based on AICPA professional standards and other related industry references. Schellman Compliance, LLC is also a globally approved Payment Card Industry (PCI) Qualified Security Assessor (QSA), ISO Certification Body, and FedRAMP 3rd Party Assessment Organization (3PAO). All of these accreditations carry with them additional requirements for defined methodologies, quality assurance, and external oversight including onsite assessments. No third parties or affiliates were involved in our examinations.

Professional Certification and Continuing Education

Schellman mandates that its delivery personnel obtain a professional certification. The majority of our professional staff maintain at least one industry certification. In order to be promoted to management, personnel must have two of the following certifications: Certified Information Systems Auditor (CISA), Certified Information Systems Security Professional (CISSP), and Certified Internal Auditor (CIA).
